

## MIC COVID-19 Student Charter

The safety of our community relies on a responsible partnership between MIC students and the College. Our COVID-19 Student Charter outlines the commitment expected by all students throughout the academic year 2020-2021 and our MIC Student Campus Safety Protocol details the measures the College has implemented to protect our community throughout the academic year 2020 – 2021.

As a student of MIC:

- I will follow MIC's Guidelines and advices as outlined in <https://www.mic.ul.ie/covid-19> and Public Health Guidelines related to reducing the spread of COVID-19. I understand that this is likely to change regularly so I will take personal responsibility for ensuring I am up to date with the latest information which is available at <https://www2.hse.ie/coronavirus/>
- I understand that in addition to adhering to public health measures, downloading and maintaining the free [COVID-19 Tracker app](#) will help us to protect each other and slow the spread of coronavirus in Ireland
- I will endeavour to take all necessary health and safety precautions to protect myself and others
- I will adhere to the mandatory and proper wearing of a face covering/mask indoors on all MIC campus environments. If I am unable to wear a face covering/mask I will provide medical verification to the [MIC Medical Centre](#)
- I will adhere to all hygiene precautions including proper hand hygiene (washing and sanitising), respiratory hygiene and relevant social distancing measures as detailed in <https://www2.hse.ie/coronavirus/>
- I will inform [MIC Medical Centre](#) if I have an underlying medical condition and/or if I am in a high risk or very high risk category which requires further support to attend campus
- I will adhere to all environmental safety measures throughout my time on campus
- I will strictly adhere to the National Guidelines outlined in <https://www.gov.ie/en/campaigns/75d92-covid-19-travel-advice/> with respect the protocols which are to be followed before, during and after any travel to and from Ireland
- I will not attend any learning environment if I have been diagnosed with COVID-19
- I will not attend any learning environment if I experience COVID-19 symptoms and/or considered a close contact to a positive case. I will follow guidance to self-isolate and get a test. In this event I will report my COVID-19 health status to [Medical.Centre@mic.ul.ie](mailto:Medical.Centre@mic.ul.ie)
- If I become unwell at college with COVID-19 like symptoms I will leave the campus immediately, returning safely to my accommodation and without compromising others. I will follow guidance to self-isolate and get a test. I will report these symptoms to [Medical.Centre@mic.ul.ie](mailto:Medical.Centre@mic.ul.ie)
- As a member of the MIC community I will behave appropriately, consider others, follow national and local advice and the public health guidelines, act responsibly and uphold the core values and policies of our College
- I know that this is an ever-developing situation – one which requires everyone's ongoing vigilance and personal responsibility.
