4. Policies & Regulations

- **Attendance:** There is a correlation between attendance at lectures and tutorials and the final grade awarded in a module. Students are also expected to spend additional time, outside of scheduled lecture and tutorial hours, on self-directed learning. - **Plagiarism & Academic Integrity:** It is important to note that academic cheating in all its forms is deemed to be a serious disciplinary offence under the Code of Conduct. Your attention is specifically drawn to the MIC Handbook of Academic Regulations and Procedures, the Academic Integrity Policy, and individual module guidelines. A lecturer reserves the right in cases of suspected plagiarism to ask individuals to explain assessment answers in person or to present their assignment formally,

- **Specific regulations, MIC Thurles programmes:** Thurles programmes have a number of capped modules, where a minimum D1 grade is required to pass the module. Lecturers will make you aware of these modules.

5. Grading & Assessment

- **Assessment Deadlines:** Strict deadlines apply for coursework submissions.
- **Late Submission of Assignments:** Timely submission of assessments is essential. Extensions can only be granted in advance of the submission deadline. The policy for late submissions is as follows: Late submissions without a pre-agreed extension will be penalised by a deduction of 5% per day off the final awarded mark (out of 100%). If you encounter extenuating circumstances affecting your ability to submit on time, it's imperative to contact the module lecturer as soon as possible to discuss possible accommodations.
- **Repeat Assessment:** Repeat assessment formats are outlined at the start of each module. It is the responsibility of the student to comply with the assessment guidelines, including submission dates and guidelines.

8. Student Entrepreneurship at MIC (MIC Limerick)

The Business Start Up Mentorship at Mary Immaculate College (MIC) Limerick Campus, led by Dr. David Cosgrave, provides aspiring student entrepreneurs with a comprehensive mentorship designed to guide them from idea to a fully operational business.

The program offers a structured framework that includes weekly hands-on mentorship. Students are coached on how to develop a value proposition, and how to validate their business ideas with real paying customers. Crucially, the mentorship helps students navigate and avoid the major pitfalls of entrepreneurship as their business grows.

This initiative already has a proven track record of success, with mentees having successfully secured external funding from prestigious bodies, including Student Inc and Enterprise Ireland, demonstrating the mentorship's effectiveness in fostering tangible and impactful entrepreneurial outcomes.

9. Undergraduate Dissertation (UGD) (Bachelor of Arts – Year 4)

The Business UGD entails exploring a research topic in the broad domain of business. Potential Business UGD supervisors and their research areas of interest will be provided in the UGD handbook circulated by the Arts office to all BA Yr 2 students in the spring semester. Please note that your area of research interest need not exactly match the supervisor research areas listed. You can contact a listed potential supervisor for advice on your proposed research topic, but this is not tantamount to supervision agreement. You will be allocated a supervisor, where possible once the research proposal process is completed and you cannot request a particular supervisor as part of this process.

The research proposal process commences with a research proposal form, which will be available early in the Yr 2 spring semester, and which needs to be typically submitted by Friday of Week 6. You will be informed of the outcome of the research proposal process by email to your student e-mail account by Friday of Week 8. This will allow you sufficient time to explore alternative option UGD supervision (if necessary), or to contact your allocated Business option UGD supervisor to obtain their signature for submission of your UGD dissertation registration form by the end of Week 10.

The business UGD process will entail various points and forms of assessment in addition to the final submission, including a Research Proposal and UGD Content Outline document submission early in Autumn semester of Yr 4 and a post-submission oral presentation. There will be an information session for all Yr 2 students on the Business option UGD and the research process early in the Spring Semester.
